Dear prospective HRCS parent,

The cost of a private school education is a matter of concern for many families. Regardless of your family's financial circumstances, paying for a quality private Catholic school education will probably require a substantial commitment of your resources over the next several years. It may surprise you to learn that a great part of our school community would not be able to pay their educational costs without financial assistance. Many of our students are able to attend HRCS only because they applied for and received financial aid.

If you consider you will need any amount of financial assistance to attend HRCS, we require you to apply at <http://www.stepupforstudents.org> and <https://www.factstuitionaid.com/facts/gaindex> immediately, prior to requesting Tuition Subsidy. We will not review any financial aid request until an application for BOTH Step up for Students, and FACTS Tuition Aid have been completed and any required documentation (income verification documents, W-2 forms) has been submitted. Proof all of the above is necessary to present your request to the Financial Assistance Committee.

While we believe that the primary responsibility for meeting educational costs rests with the student's family, *Step Up for Students Scholarship* and *F.A.C.T.S. Tuition Grant & Aid Assessment Service* can help. Although these organizations are not able to meet the full need of every student, by combining the various types of funds available we use every method possible to coordinate adequate resources to enable you to invest in a Catholic School education for your child (ren).

Please fill out the HRCS Income Verification Survey to help us determine the amount of funds that will be needed to provide Financial Aid to eligible students in HRCS. The information requested on this survey is confidential. DEADLINE FOR APPLICATIONS (2015-16 School Year): May 1st, 2015.

What is the Step Up For Students Program?

Step Up For Students is an initiative of the Florida Tax Credit (FTC) Scholarship Program. This innovative program provides K through 12th grade education scholarships for qualifying low-income students who are entering Kindergarten through 5th Grade or attended public school the previous year. The scholarship gives parents the opportunity to choose the Kindergarten through 12th grade school that best meets their children's needs. The scholarship covers up to \$4,880.00 for private school tuition. The parents are responsible for the monthly payment of the difference between the scholarship and the school tuition. The scholarship only covers the cost of tuition and does not include registration, or the cost of the school uniform.

You may qualify for a scholarship if:

- Your child is entering 6th through 12th grade and attended a Florida public school for the entire previous school year OR is entering Kindergarten through 5th grade.
- Your household income meets the income eligibility guidelines set forth by the Step Up For Students organization.

Non-supporting and Non-Catholic Rate:

1 Child:	\$ 6,905 (12 months = \$ 575.42 a month)
2 Children:	\$13,810 (12 months = \$1,150.84 a month)
3 Children:	\$20,715 (12 months = \$1,726.25 a month)
4 Children:	\$27,620 (12 months = \$2,301.67 a month)
5 Children:	\$34,525 (12 months = \$2,877.09 a month)

In the 2015-2016 Academic year, any family receiving subsidy (Step-Up-For-Students, VPK, McKay, Parish Assistance, etc.) will not be granted the multi-child discount

FEES:

RE-REGISTRATION FEE IS \$150.00 PER STUDENT FOR CURRENTLY ENROLLED STUDENTS IN GRADES PK-3 THROUGH 8TH GRADE:

This fee includes Diocesan fees and is non-refundable. Re-registration for currently enrolled students is open from January 26th to March 13, 2015. After March 20, 2015 re-registration fee is \$250.00 no exceptions.

REGISTRATION FEE IS \$250.00 PER STUDENT IN GRADES PK-3 THROUGH 8TH GRADE:

This fee includes Diocesan fees and is non-refundable. This fee is due at the time of registration.

INSTRUCTIONAL FEES ARE \$375.00 PER STUDENT PER YEAR IN GRADES PK-3 THROUGH 8TH GRADE:

This fee is due at the time of registration and or re-registration or may be applied to your FACTS account with monthly payments of \$31.25 if paid over 12 months. Please note that this fee is NON REFUNDABLE and must be paid in full even if you leave the school before the end of the school year.
